Kind reference is drawn to the earlier letters of this Department dated 13/01/2020 and 24/09/2021 on the above subject (copies enclosed).

- 2. Vide the said letters, it was informed that reports of suspected duplicate beneficiaries, generated through national de-duplication process on the ration cards/beneficiaries' data being received in the Central Repository from all States/UTs are available on the IM-PDS portal (http://impds.nic.in/impdsdeduplication). These reports are accessible to the respective nodal officers of all States/UTs through their login credentials. A summary of the latest State/UT-wise report on Intra-State and Inter-State de-duplication is annexed herewith for ready reference.
- 3. All States/UTs were, therefore, requested to initiate the verification process of all suspected cases and if necessary, it was requested to go for field/door-to-door verification before undertaking required cleansing or data correction of such beneficiaries. In case of inter-State duplicity of beneficiaries, the concerned States/UTs were requested to coordinate and undertake mutual verification of such duplicate beneficiaries, and shall leave only one active record in only one of the State/UT, and as far as possible, with the consent/preference of the concerned beneficiary.
- 4. Keeping in view the importance of exercise in checking the pilferage of ration to unintended beneficiaries, it is once again requested that the above verification and cleansing/correction exercise may kindly be completed by 31st December 2021 and an Action Taken Report (ATR) shall be shared with this Department.
