Many technological interventions have been made to prevent leakages. Simultaneously, it has been our endeavour to improve the profitability of these FPSs to ensure that these shops remain viable and vibrant offering multitude of services and improved beneficiary experience. In this regard, in coordination with States/UTs, various initiatives have been undertaken by this Department so as to provide new business avenues to FPS dealers

- 2. Kindly recall our discussion regarding "PM-WANI" which has been launched by your department to proliferate broadband through Public Wi-Fi networks. This initiative can be leveraged towards improving the FPS viability, wherein at least 40%-50% FPS can function as a Public Data Office under PM-WANI and may be able to earn extra income from selling the internet services. This will also greatly help in bringing the yet uncovered and remote areas under the digital framework.
- 3. I, therefore, request you to advise concerned Circle offices to get in touch with the State Food & Supplies Departments to generate awareness about this initiative amongst the FPS dealers and guide them to register themselves as PDO wherever feasible. I am also advising State Food Secretaries to approach telecom orficers in the state Capitals to hold preliminary discussions to explore real opportunities.
